1.0 Tender submission:

- 1.1 The Tender should be submitted personally or sent by Registered post / Courier, so as to reach 'The Managing Director, Jalgaon Jilha Sahakari Dudh Utpadak Sangh Maryadit', Jalgaon on or before **26-12-2025 up to 5:00 PM**
- 1.2 Tender received by E-mail will not be considered.
- 1.3 Tenderer have at least 2/3 years of experience to supply molasses. Please enclose respective documents.
- 1.4 Corrections, if any, shall be made by crossing out, initialing, dating and re- writing.

2.0 Earnest Money:

- 2.1 The Tenderer shall have to pay earnest money of **Rs. 3,50,000/**-(Rupees Three Lac Fifty Thousand only) Deposit as EMD by Cash/RTGS /NEFT only. Mention UTR No, dated, amount/D.D. no,.dated, amount /Cash deposited no., date and amount on cover of tender envelop.

- 3) Parties will have to fulfill the required clearance certificate from Excise department to lift the molasses and licensing with various government agencies as statutory requirement.
- **4.0 Quality:** The said molasses should not be Old than 1 or 2 crushing seasons.

5.0 Billing:

- 5.1 Apart from submission of Molasses bill by sugar factory to JMU, balance amount bill will be submitted to tender awarded party as transportation to JMU & we will deduct GST if any from transportation bill.
- 5.2 If party is GST registered then provide bill with GST rate and has mandatory to give bifurcation of GST bill. If the party is Non-registered then provide Declaration & Bill of supply (transportation and supply of goods).
- 5.3 Kindly clear the terms regarding reverse charge mechanism applicable on transport service.
- **6.0 PRICES:** The prices should be quoted F.O.R. Cattle Feed Plant, Nashirabad, inclusive of GST, insurance & transportation charges etc. Billing should be bifurcated as per commercial format.
- **7.0 INSURANCE**: Insurance shall be arranged by the party at own cost. The JMU will not be responsible for any transit damages and losses.
- **8.0 INSPECTION:** The inspection of received material will be carried out in our CFP lab only. If goods are rejected due to defective or wrong supply, the report of our Lab in this respect shall be final and no correspondence on the subject would be entertained. The rejected molasses will not be unloaded at CFP, Nashirabad & replacement of molasses must be given immediately by party with fulfilling all statutory requirements.
- **9.0 PAYMENT**: Payment shall be release after receipt and approval of molasses by cheque in 8 to 10 lots.
- **10.0 PENALTIES:** If Supplier does not fulfill the material quantity after receipt of Purchase Order, then EMD amount will be forfeited and JMU will purchase material from other party and actual losses will be recovered. Those Transporters/ Supplier/Sugar Factory, who failed to supply the molasses earlier, will not be considered for tender/ further process.

11.0 TERMINATION OF CONTRACT:

The Managing Director, JMU reserves the right to cancel the contract at any stage without prior notice.

12.0 FINAL AUTHORITY:
