- 1.3 Suppliers / Traders / Brokers have at least 2/3 years of experience to supply of Raw Material & A' Twill Gunny Bag for Cattle Feed Plant, Please enclose respective documents, If the tenderer is already exist in our supplier / Vendor list then not compulsory.
- 1.4 Corrections, if any, shall be made by crossing out, initialing, dating and re- writing.
- 1.5 Broker must provide name of the suppliers within two days from the date of confirmation of contract.

### **3.0 PRICES:**

**3.1** The prices should be quoted F.O.R. Cattle Feed Plant, Nashirabad, including of packing & forwarding, insurance & transportation charges, GST and TCS will be paid extra at actual. All the material should reach uniformly at our Cattle Feed Plant, Nashirabad.

**3.2** Supplier has to quote the rate as per attached commercial format /should be covered commercial format points on your letter head.

### **4.0 PAYMENT:**

1. For Raw Material Cattle Feed

100% payment will be released within 30 days from the date of receipt & final acceptance of the material.

### **GENERAL TERMS AND CONDITIONS**

1. Packing should be Sound second hand Gunny Bags without patches, otherwise deduction @ Rs. 4.00 per bag. In case the supply of Raw Material is in Plastic or Jute/ Laminated, Joined bags a sum of Rs.4/- will be deducted per bag. If entire supply is made in Plastic or Plastic Jute jointed bags a sum of Rs. 60/- per MT of Raw Material will be deducted.
2. Goods should be fresh, free from adulterants, insects and infection rancidity and undesirable & objectionable odour. It should be free from dirt, sand extraneous matter including iron and metallic pieces
3. The time should or time limit for delivery must be adhered to the order is liable to be cancelled at purchase option if not executed in time.
4. All Correspondence should be in legible and clean hand writing, preferably typed in the language English, Marathi or Hindi. The buyer shall be free to ignore, read or interpret in his own way any letters received in the manner, and, or in the language, other than stated above.
5. After expiry of delivery date, if supplier supply the goods or supply excess quantity then it will be accepted at reduced rate (Purchase order or Next contract rate whichever is lowest) subject to following penalties + 18% GST Extra.
  - a. Rs.100/- per MT for First 4 days from the date of expiry of delivery schedule.
  - b. Rs.150/- per MT for next 3 days after clause no (a).
  - c. After 7 days the contract may be cancelled by recovering the rate difference along with penalties incurred to sangh.
6. In case of failure of supply, if feed production suffered or delayed then we are free to purchase material from other supplier and the actual losses plus penalty of Rs.100/- will be penalize by raising the debit note

accordingly. If Supplier deposit respective penalty in sangh account then only said supplier will be allowed to participate in next tender.

7. After confirmation of rate, broker should have to provide the supplier names within two days. Confirmation should include supplier's full address, mail ID & contact details. If broker failed to provide supplier name within 2 days, we are free to purchase material from other broker / supplier and amount of rate difference will be debited to broker's account & will be informed accordingly. If broker deposit respective rate difference amount in sangh account then only broker will be allowed to participate in next tender. If such incidence happened thrice in a year the broker will be blacklisted.
8. Please send along with the dispatch of materials, your delivery challan, dispatch Note/letter, weighment slip. Quoting number of purchase order, mode of transport, Truck number, quantity dispatched & other required particulars to our Sangh. If material dispatched on freight to pay basis, send letter separately.
9. Bill shall be in the name of Jalgaon Jilha Sahakari Dudh Utpadak Sangh Maryadit, Jalgaon & sent to our Sangh. Please send Tax invoice & E- Way Bill (Mention- Consignee/ Consignor & Shift to address) along with same lorry at our Cattle Feed Plant, Nashirabad.
10. The time schedule or the time limit for delivery must be adhered to. The order is liable to be cancelled at purchase's option if not executed in time. The Suppliers will be required to supply goods/material in case of time schedule getting over, in consultation in writing with the buyer.
11. In such circumstances / events, the buyer will accept the material at the prevailing rate or purchase rate, whichever is less.
12. The suppliers shall supply goods according to buyer specification, terms or and conditions strictly within the time stipulated. The supply of goods which is not according to specifications, terms and condition shall be rejected as a whole or in part after inspection and analysis by buyer and shall be considered as non supply against the order. The suppliers should lift the rejected goods from the factory within seven days after intimation. The supplier shall incur storage charge at the rate Rs.10/- per ton per day. The rejected goods shall be lying in the Premises of the buyer's Factory at supplier's risk and responsibility along with storage losses in weights. The buyer shall be free to dispose off or destroy the rejected goods, if not lifted within the said time, on supplier's account by giving notice to the supplier.
13. If the L.R. Is not received in time, wharfage charges will be on the seller's account.
14. Weighment, Sampling, measurement and analysis at our factory shall be final.
15. Guarantee of analysis shown in the purchase order is always on such basis and not on moisture free basis.
16. When fix quantity is given say 100 M. Tons, variation to adjust complete truck or wagon load to extent 2 percent between the quantity supplied and that specified here in shall be accepted by the buyer provided that in no case such variation shall exceed 5 tons, In case the supplier desires to cross the above limit of variation he will be required to obtain confirmation from the buyer in advance. Where variation of quantity is already provided in P.O. Say 100 to 110 Tones or so, variation of 2

percent quantity supplied will not be allowed i.e. Supplier will have either to supply minimum or maximum quantity.

17. If sealed samples are required, supplier representative may collect the same at the time of delivery of goods. However if the samples are required, afterwards, the same will be given only from the samples drawn already by the Plant staff.
18. Second Test for estimation of moisture will not be allowed.
19. Goods must be suitable for use in cattle feed, otherwise the supplier shall be held responsible for all the consequential liabilities arising out of it.
20. In case you prefer 2nd Test & result is found to differ to the extent of only + 0.5% then the Union last test would be accepted as final.
21. TERMINATION OF CONTRACT: The Managing Director, JMU reserves the right to cancel the contract at any stage without prior notice.
22. If TCS 194Q of Income Tax Act Applicable, you are requested to provide TDS declaration as per attached Format in ANNEXURE – III

**23. FINAL AUTHORITY:**

- At the time of submitting the Tender, the Suppliers / Brokers shall supply detailed information about their activities.
- In matters of interpretation of the above clauses, the decision of the Managing Director, JMU shall be final and binding on all concerned.
- For all disputes the jurisdiction shall be Jalgaon. No court outside Jalgaon will have any jurisdiction.


**24. ARBITRATION:**

In case of any dispute, if arises between the parties, relating to any terms and conditions of the Tender/Agreement and/or regarding the Agreement/Tender before or after the filing of the Tender and/or execution of the Agreement, any party may refer the dispute to a Sole Arbitrator who will be the Managing Director of JMU or a person nominated by him whose decision and award shall be final and binding to both the parties. The arbitration proceedings shall be under and accordance with the provision of Arbitration and Conciliation Act 1996.

We, **Jalgaon Jilha Sahakari Dudh Utpadak Sangh Maryadit, Jalgaon**, having PAN **AAIAJ0708K** hereby inform you that our total sales/gross receipts/turnover from Business during FY 2020-21 has been more than Rs.10 Crore. Therefore, as per the provisions of Section 194Q, inserted in the Income Tax Act 1961 vide Finance Act 2021 with effect from 01.07.2021, are applicable to us. Hence, we shall be deducting tax at source at per provisions of above section from purchase consideration paid/ credited on or after 01.07.2021 to you against supplies made by you at the rate 0.1 percent of purchase consideration paid / credited exceeding Rs. 50 lacs during the current financial year **2023-2024**.

Since, we are liable to deduct tax at source u/s 194Q of the Act, you may ensure not to take any action to collect tax at source under section 206C(1H) of the Act w.e.f. 01.07.2021, in case provisions of section are applicable to you considering your amount of turnover and our purchases being of more than Rs. 50 lacs.

You are also requested to intimate your Permanent Account Number. In case you fail to provide your PAN, tax will be deducted at the rate of 5 % instead of 0.1 % in terms of Section 206AA of the Act.

Further, you are also required to confirm that in your case amount of TDS/TCS was Rs.50,000/- or more in previous years relevant to **Assessment Years 2021-22 and 2022-23** and you have filed your returns of income for these assessment years according to section 139(1), otherwise tax is required to be deducted at the rate of 5 % in terms of Section 206AB of the Act.

You may send to us your declaration in the enclosed draft on or before **30.04.2023** to enable us to take note of same and modify our accounting software accordingly. In case your declaration is not received by us by the above date, we will modify our software to deduct tax at the rate of 5 % and it would be difficult for us to take corrective action to reduce the rate during the current financial year.
